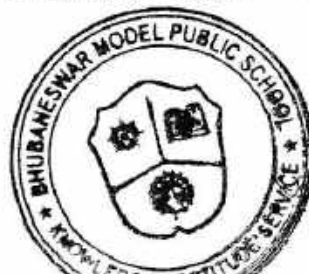

Pursuant to decision of the committee constituted vide School and Mass Education Department Notification No, 9317 dated. 26.05.2017 in its meeting held on 26.05.2017 No Objection Certificate is granted in respect of the following Higher Secondary School for the purpose of obtaining affiliation from the CBSE with the terms and conditions noted hereunder.

1	Bhubaneswar Model Public School, N-5A/1697, Jaydev Vihar, Bhubaneswar, Odisha	CBSE

1. Medium of instruction in the Higher Secondary School shall be English but Odia shall be taught as a subject in the institution.
2. The Higher Secondary School shall be opened for inspection by the Inspecting Officers of School and Mass Education Department.
3. No financial assistance and grant-in-aid (both recurring and non-recurring) shall be claimed by the institution from the Government at any point of time for meeting the salary cost and its component towards teaching and non-teaching staff appointed by the Managing Committee.
4. The Managing Committee of the Higher Secondary School will not shift the present location of the School without prior approval of Government in School and Mass Education Department.
5. The managing committee shall be constituted in accordance with the Section-7 of Orissa Education Act, 1969/ Guidelines of CBSE.
6. The Managing Committee shall ensure the continuity of all eligibility criteria for grant of NOC if any deterioration from present status of the Higher Secondary School is detected at any point of time then the N.O.C. shall be withdrawn.
7. All Higher Secondary Schools be registered in web-portal in OPEPA website.
8. If at any point of time, it is found that information submitted by the Higher Secondary School is not in conformity with the field position, appropriate legal action against the school authority will be initiated besides withdrawal of NOC.
